

The Ateneo Chemistry Society (ACheS) is hosting its annual chemistry competition, the Ateneo Chemistry Olympiad (AChO) 2020 with the theme, *Sumukbó sa Lipunan*, on February 15, 2020 at the Ateneo de Manila University, Katipunan Avenue, Loyola Heights, Quezon City.

AChO 2020 will be comprised of three major segments:

- 1. Written Test and Practical Laboratory Exam (Elimination Round),
- 2. Quiz Bee (Final Round), and
- 3. Electives and Exhibit.

The competition aims to promote academic excellence in chemistry and to impart its applications among high school students.

The target participants are Grades 9-12 students from public and private schools.
