

**RESETTING OF THE ASSESSMENT OF THE 2019 REGIONAL SCHOOLS PRESS
CONFERENCE (RSPC) OUTPUTS CUM REGIONAL COACHING OF THE 2020 NATIONAL
SCHOOLS PRESS CONFERENCE (NSPC) QUALIFIERS**

1. In view of DepEd Memorandum No. 23, s. 2020 which gives authority to units in the Central Office, Regional Offices, Schools Division Offices, and schools to resume the conduct of national, regional, and/or other off-campus activities, this Office announces that the new schedule for the conduct of the **Assessment of the 2019 Regional Schools Press Conference (RSPC) Outputs cum Regional Coaching of the 2020 National Schools Press Conference (NSPC) Qualifiers** shall be on March 2-3, 2020 (Batch 1) and March 4-5, 2020 (Batch 2) respectively at the same venue.
2. Relative to this, the Schools Division Offices (SDOs), through the Division Journalism Coordinators, are tasked to submit a new confirmation of the division delegation using the updated template attached to this Memorandum not later than February 28, 2020, taking into account the parental consent of the students who will participate in the regional activity and the willingness of participants to attend the NSPC even if it resumes at a later date. The invited resource speakers are likewise requested to confirm their availability and attendance to the above-mentioned dates.
3. To ensure the smooth management of the activity and address logistical concerns, the CLMD Supervisors are tasked to assist the Regional Management Team by providing additional manpower during the event.
4. All other provisions issued in Regional Memorandum No. 63, s. 2020 which are consistent to this issuance shall remain in force and in effect.



5. Immediate dissemination of and compliance with this Memorandum are desired.
