

- 5. The participants of the said activities are personnel and officials who were nominated by the Central and Regional Offices per Memorandum re: Request to Nominate Evaluation Committee Members for the Recognition of the Professional Development Programs and Courses for Teachers and School Leaders dated May 11, 2020.
- 6. Participants are also requested to have access to a laptop, a headset with microphone, a DepEd email account and a standard internet connectivity with 5 mbps speed or higher.
- 7. The online platform that will be used in the orientation is **Google Classroom**. Hence, the participants are requested to familiarize themselves with the said platform.
- 8. Each participant shall be given load allowances worth of P100.00 per day. The said cost will be downloaded to RO/SDO, upon the issuance of Financial Guidelines on the use/provision of the said expenses, and it shall be charged against NEAP Human Resource Development (HRD) Funds, subject to the usual accounting and auditing rules and regulations.
