**REGIONAL MEMORANDUM**

**TELECONFERENCE WITH THE DIVISION EDUCATION PROGRAM SUPERVISORS IN MOTHER TONGUE BASED-MULTILINGUAL EDUCATION (MTB-MLE), KINDERGARTEN EDUCATION (KE), AND SENIOR HIGH SCHOOL (SHS) PROGRAMS**

To: Schools Division Superintendents  
All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a Teleconference with the Division Education Program Supervisors (EPS) in Mother Tongue Based-Multilingual Education (MTB-MLE), Kindergarten Education (KE), and Senior High School (SHS) Programs on June 16, 2020.
2. The activity aims to:
  - a. share some initiatives in response to the pandemic and thresh-out issues and concerns relative to the implementation of the programs;
  - b. explore possible solutions and recommendations to ascertain continuous learning amidst the health crisis;
  - c. discuss new DepEd policies in relation to KE and SHS Work Immersion;
  - d. prepare the list of writers who shall contextualize the Alternative Delivery Modules for Kindergarten and Mother Tongue; and
  - e. submit SHS related data for School Year 2019-2020 via online (TESDA National Certification, Curricular Exits, and Work Immersion).
3. The participants to this activity are the OIC-CLMD Chief, RO Focal Persons for SHS and Technical Vocational Livelihood (TVL), and Division Education Program Supervisors of the above-mentioned programs to include the EPS in charge of TVL who are working in tandem with the SHS Division Coordinators as regards to SHS program implementation.
4. The concerned Division Supervisors are required to prepare a 3-minute slide deck presentation of their initiatives and issues and concerns with corresponding solutions and recommendations.

6. The meeting link for this activity shall be shared by the Regional Focal Person on June 15, 2020.
