**CLOSURE OF ST. ANNE'S PLAYSCHOOL, ORMOC CITY DIVISION,
WITH SCHOOL ID. NO. 404789**

1. The Department of Education, Regional Office No. VIII through the Quality Assurance Division (QAD) announces the **TEMPORARY CLOSURE** of **ST. ANNE'S PLAYSCHOOL**, Ormoc City Division, Region VIII with **school ID No. 404789**, effective SY 2020-2021. The closure of the school is through voluntary withdrawal of Permit under section 34 of DepEd Order No. 88 s. 2010 per communication received from Leslie Maria Merced Emilia A. Gatchalian, School Administrator and indorsed by the Schools Division Superintendent of Ormoc City Division. Said school has been greatly affected by the escalating health crisis brought about by the novel corona virus and that the school administrator decided to temporarily close the school.
2. The Schools Division Superintendent is hereby directed to inform the school to submit all pertinent documents to the division concerned for safekeeping.
3. Immediate dissemination of and strict compliance with this Memorandum are desired.

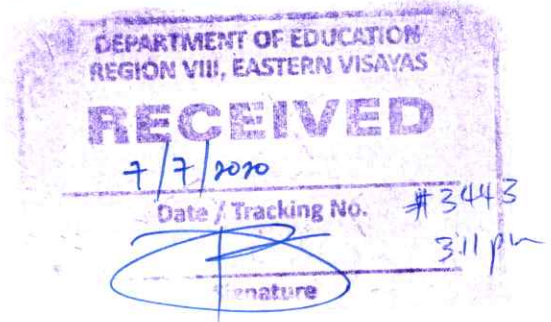

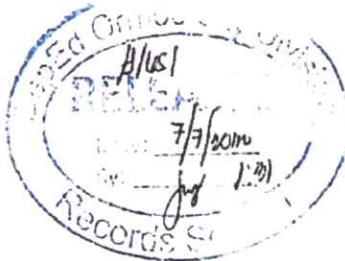

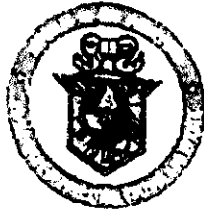
