### *THE CRITERIA ARE:*

- The composition should be original and not yet published in any digital platforms;
- The composition Should be composed with a Filipino descent , 35 years and below;
- The composition can be any genre –pop,rock,world,ethnic ,rap or folk;
- The content of the song should dwell on love for the environment, climate action, nature and other related topics;
- Message should imply optimism;
- Lyrics with music shall be judged as one;
- The song can be composed by one person or collectively. As a primary composer, a person can only have ONE entry. However, a person can work with others as a collaborator.
- The length should be less than 4 minutes including intros and interludes.
- The composer/s should provide us with a good quality demo but not necessarily recorded in studio; It can be with accompanied with basic instruments only. Song rights of finalists will follow the accepted Philippine copyright laws accordingly.

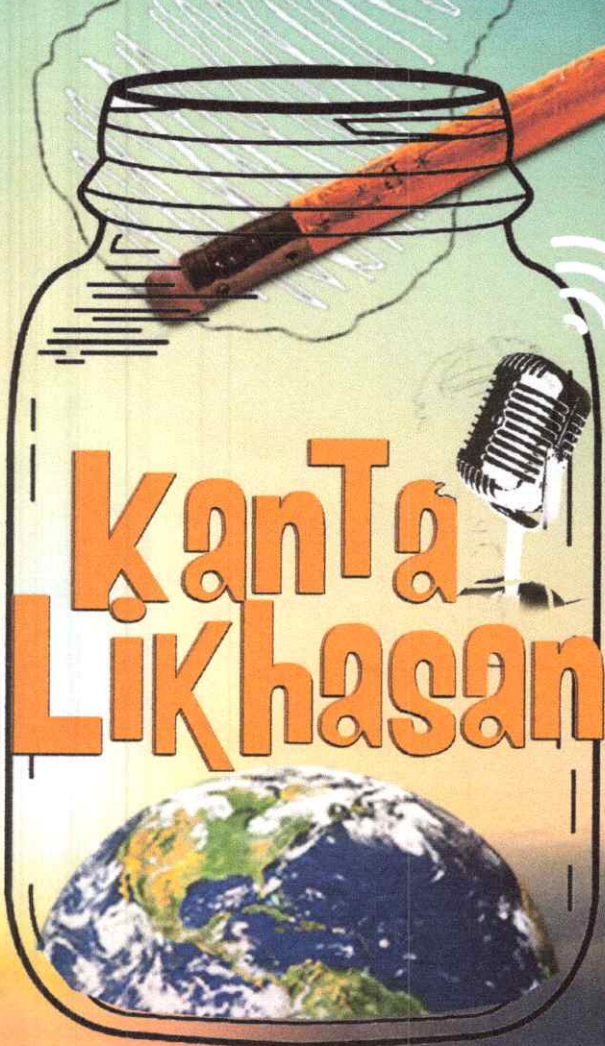
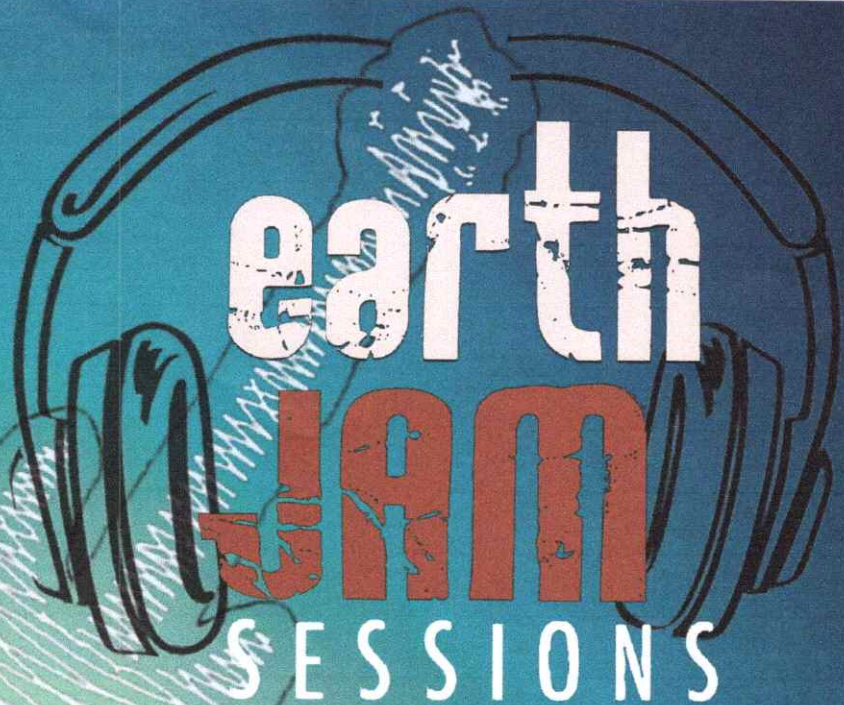
