CLOSURE OF HINDANG LEARNING SCHOOLHOUSE, INC., HINDANG, LEYTE, DIVISION OF LEYTE

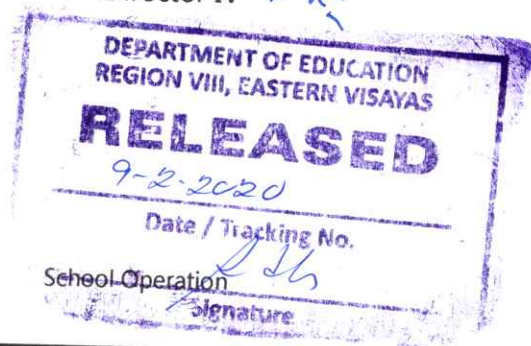

The Department of Education, Regional Office No. VIII through the Quality Assurance Division (QAD) announces the **TEMPORARY CLOSURE** of **HINDANG LEARNING SCHOOLHOUSE, INC.**, Hindang Leyte, Division of Leyte, Region VIII, effective SY 2020-2021. The closure of the school is through voluntary withdrawal of Permit under section 34 of DepEd Order No. 88 s. 2010 per communication received from Cornelio M. Sevilla, Chairman, Board of Trustees and indorsed by the Schools Division Superintendent of Leyte Division. Said school has been greatly affected by the escalating health crisis brought about by the novel corona virus and that the school head decided to temporarily close the school.
2. The Schools Division Superintendent is hereby directed to inform the school to submit all pertinent documents to the division concerned for safekeeping.
3. Immediate dissemination of and strict compliance with this Memorandum are desired.

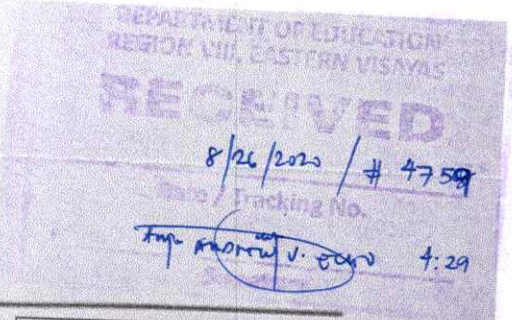



We regret to inform that HINDANG LEARNING SCHOOLHOUSE, INC. located at Barangay Poblacion I, Hindang, Leyte is not prepared to open its classes this School Year 2020-2021 due to various important health protocols which the school could not comply in this pandemic crisis.

It will be impractical to adopt learning module proposed by DepEd in the kindergarten classes without resorting to face to face contact as kids are still in the early learning stage. These kids need physical monitoring to enable them to grasp lessons in writing, reading, etc.
