

**CLOSURE OF XAVIER EARLY ACADEMY HOUSE, INC.

1. The Department of Education, Regional Office VIII through the Quality Assurance Division (QAD) announces the **PERMANENT CLOSURE** of **XAVIER EARLY ACADEMY HOUSE, INC.**, 45 Juan Luna St. Tacloban City, Tacloban City Division, Regional Office VIII with School ID No. **455008**, effective SY. 2020-2021. The closure of the School is through voluntary withdrawal of Permit under section 34 of DepEd Order No. 88, s. 2010 per communication received from Minerva Peregrino-Molon, School Administrator and endorsed by the Schools Division Superintendent of Tacloban City Division. Said school has been greatly affected by the escalating health crisis brought about by the novel corona virus and that the school head decided to close the school.
