WITH SCHOOL ID. NO. 452510**

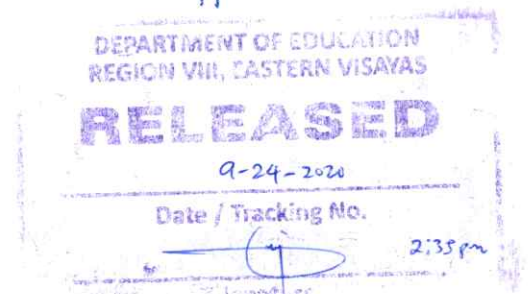
