The activity aims to discuss new ways of teaching learners with special needs in light of the current health crisis.

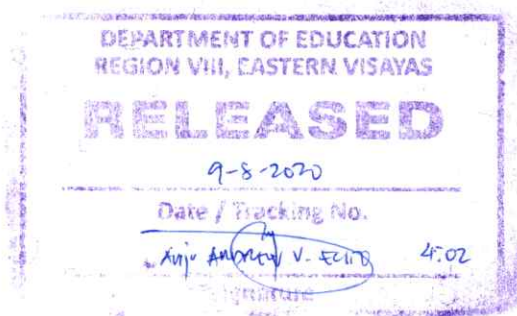
