**DOWNLOADING OF EARLY LANGUAGE LITERACY AND NUMERACY (ELLN)  
COMPREHENSIVE RELEASE FUNDS TO SCHOOLS DIVISION OFFICES**

To: Schools Division Superintendents  
All Others Concerned

1. In line with the implementation of the Early Language Literacy and Numeracy (ELLN) and as a support to DepEd Memorandum No. 173, s. 2019 "Hamon: Bawat Bata Bumabasa", this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download the ELLN Comprehensive Release Funds amounting to **Thirty-Eight Thousand Four Hundred Sixty-One Pesos (Php38,461.00)** per Schools Division Office.
2. The program support funds shall be used to cover expenses for the region and division wide trainings of untrained Public Schools District Supervisors (PSDSs), School Heads, and Teacher-Learning Action Cell (LAC) Facilitators and/or a select teacher to handle the school reading program for the **Training on the Adoption of the Blended Delivery Model for Teacher Professional Development (TPD): Roll Out of ELLN Digital and Training on Literacy Instruction**. The final output of the division wide training will be a LAC Plan for the conduct of the school-based LAC sessions.
3. The Schools Division Superintendents through the Chiefs of the Curriculum and Implementation Division shall submit a Financial Report on the Utilization of the downloaded Funds not later than December 18, 2020 to [clmd.region8@deped.gov.ph](mailto:clmd.region8@deped.gov.ph) cc [teodorico.pelino@deped.gov.ph](mailto:teodorico.pelino@deped.gov.ph).

In line with the implementation of the ELLN Program, please be informed that the Program Support Funds amounting to Five Hundred Thousand Pesos (Php500,000.00) per region was comprehensively released to the regions. Further, this Department has already requested an additional One Million, Two Hundred Fifty Thousand Pesos (Php1,250,000.00) per region from the Department of Budget and Management of the Central Office for direct release to the regional offices. Hence, a total of **One Million, Seven Hundred Fifty Thousand Pesos (Php1,750,000.00)** per region shall be used as program support funds for ELLN.

The support funds shall be used to cover the region wide training of untrained Regional and Division Supervisors, Public Schools District Supervisors, School Heads and one (1) select teacher to handle the school reading program for the Training on the Adoption of the Blended Delivery Model for TPD: Roll Out of ELLN Digital and Training on Literacy Instruction as a support to DepEd Memorandum No. 173, s. 2019 "Hamon: Bawat Bata Bumabasa". The final output of the regionwide training will be an implementation plan for the division and the conduct of the school-based Learning Action Cell (LAC) sessions.
