SPECIAL VIRTUAL CONVERGENCE OF EDUCATION LEADERS (SV-CEL)

1. A Special Virtual Convergence of Education Leaders (CEL) shall be conducted on Tuesday, September 1, 2020 starting 9:30 am to 12 noon.
2. The objectives of this e-meeting are as follows:
 - a. Present the results of the dry runs/simulation activities on the implementation of the Learning Modality/ies conducted by three Schools Divisions Offices;
 - b. Devise plans to strengthen/sustain the good practices that were identified during the actual activities;
 - c. Suggest interventions to address the gaps that have been observed by the Schools Divisions relative to the conduct of the dry runs/simulation activities; and
 - d. Provide valuable inputs to enhance the mode of delivery of the Divisions.
3. The expected participants are the following, to wit:

6. Whatever agreements that shall be forged and proposals that shall be made by the participants will form part of the good practices of the Region to be utilized as guides in delivering the various modalities adapted by the Divisions.
