SECOND SPECIAL VIRTUAL CONVERGENCE OF EDUCATION LEADERS (SV-CEL) ON THE RESULTS OF THE DRY RUN

To: Director III
Schools Division Superintendents
Regional Office Division Chiefs
All Others Concerned

- 1. A Second Special Virtual Convergence of Education Leaders (CEL) shall be conducted on September 11, 2020 starting 9:00 am to 12 noon.
- 2. The objectives of this virtual convergence are as follows:
 - a. Present the results of the dry runs/simulation activities on the implementation of the Learning Modality/ies conducted by three Schools Divisions Offices;
 - Devise plans to strengthen/sustain the good practices that were identified during the actual activities;
 - Suggest interventions to address the gaps that have been observed by the Schools Divisions relative to the conduct of the dry runs/simulation activities; and
 - d. Provide valuable inputs to enhance the mode of delivery of the Divisions.
- The expected participants are the following, to wit:
 - a. Assistant Regional Director;
 - b. Functional Divisions Chiefs;
 - Schools Division Superintendents;
 - d. Assistant Schools Division Superintendents;
 - e. Curriculum Implementation Division Chiefs; and
 - f. Schools Governance and Operations Division Chiefs.



- 4. The Schools Division Superintendents of Ormoc City, Tacloban City and Biliran Divisions shall present the results of the dry runs/simulation activities that have been conducted, focusing on following salient features, to wit:
- a. The Ormoc City Division shall focus in its experiences as a city division on the process of reproduction, distribution and retrieval of modules;
- b. The Biliran Division shall center its presentation on the general findings of the dry run as a medium-sized division; and
- c. The results of the dry run on television/radio broadcast as a supplementary learning modality shall be the subject of Tacloban City Division's report.
- 5. After the report of the findings have been presented, the three SDS-presenters may answer some clarificatory statements from the participants.
- 5. The insights, reactions, and additional inputs shall be solicited from the Functional Division Chiefs, SDSs and ASDSs and other participants for the improvement of the learning modality delivery using the attached template which will be submitted to oard.region8@deped.gov.ph before 5'oclock pm of even date.
- 6. Whatever agreements that shall be forged and proposals that shall be made by the participants will form part of the good practices of the Region to be utilized as guides in delivering the various modalities adapted by the Divisions.
