1. In compliance with the attached DepEd Memorandum DM-CI-2020-00250 re: Addendum to DM-CI-2020-00224 entitled Online National Training for Kindergarten Remote Teaching and Learning: Developmentally Appropriate Responses in the Time of Covid-19, this Office, through the Curriculum and Learning Management Division (CLMD), requires the attendance of the Public Schools District Supervisors (PSDSs) to the said national activity on September 21-24, 2020.

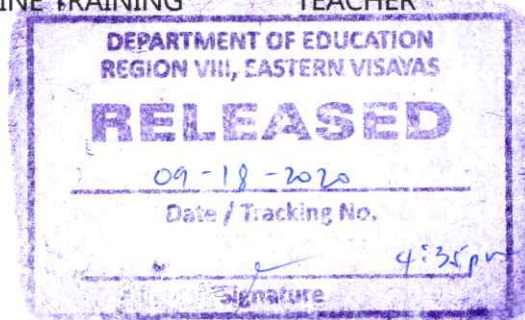
