The target participants are principals/school heads, coordinators, department heads, and supervisors from both public and private senior high schools.

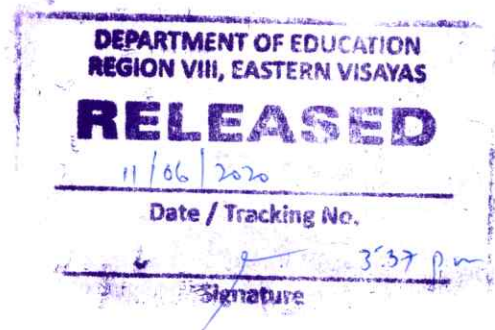

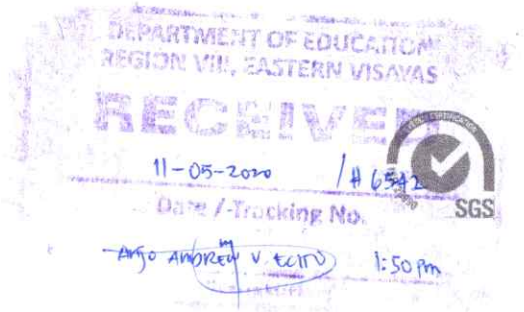



We hope that this letter finds you in the best of health amidst the situation that we are currently in.

We are glad to inform you that Creotec Philippines has designed a program to provide relevant work immersion experience to our Senior High School students despite the challenges of the pandemic.
