SCIENCE FILM FESTIVAL

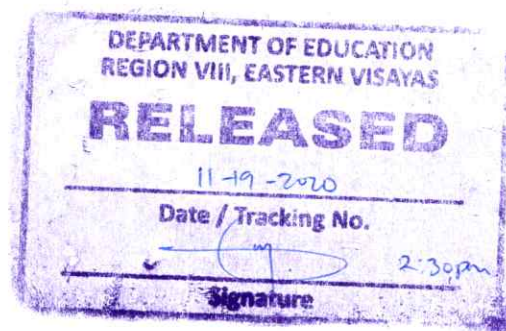

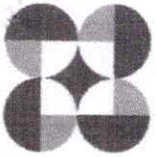
The interested participants are to register at www.bit.ly/RegSFFPh20, from which an email containing the link to the films will be sent. For more information, refer to the attachment.

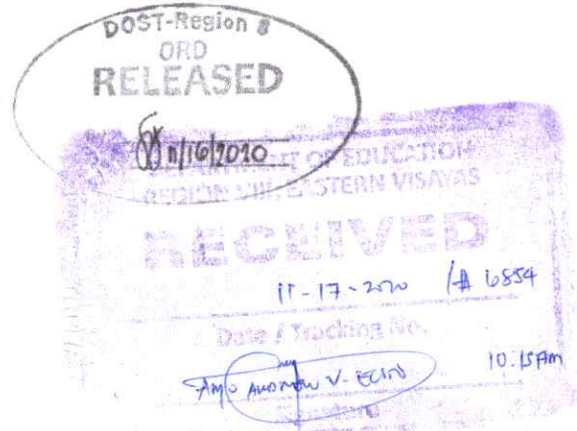
