The Online Book Fair aims to

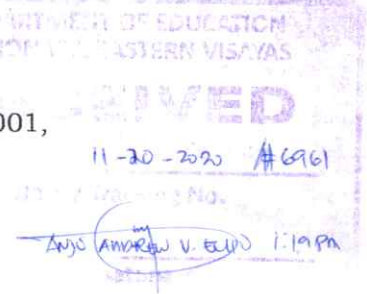
1. redefine and showcase the largest and most comprehensive collection of books, magazines, comics, educational aids, and allied materials;

5. provide a venue where an exchange of ideas can take place among publishers, booksellers, librarians, academicians, writers, printers, manufacturers and distributors of educational aids and all those connected with book development, publishing, printing, computer distributors or retailers, school and office supplies, computer and learning institutes, and related trade from within and outside the Philippines; and
6. encourage authorship and improve the literacy and creative content of books published.

All DepEd personnel, learners, and other stakeholders are invited to attend this activity.

This is also subject to the no-collection policy as stated in Section 3 of Republic Act No. 5546, An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges, and Universities (Ganzon Law).
