WORKSHOP ON THE DEVELOPMENT OF POLICY FOR VALUES EDUCATION PROGRAM (VEP)

To: Minister, Basic, Higher and Technical Education, BARMM Regional Directors Schools Division Superintendents All Others Concerned

- 1. In support to the 1997 Philippine Constitution, which stresses the role of educational institutions to inculcate and strengthen ethical and spiritual values, and develop moral character and personal discipline; and the approval into law of **Republic Act No. 11476** or the "GMRC and Values Education Act", the Bureau of Learning Delivery Teaching and Learning Division (BLD-TLD) will conduct a virtual Workshop on the Development of Policy on Values Education Program on December 09-18, 2020.
- 2. The main goal of the activity is to redefine the policy on Values Education Program. It specifically aims to:
 - a) review the existing policies in support to the implementation of Values Education to determine which policies need to be strengthened, amended or revised;
