Subject: **2020 NATIONAL DRRM YEAR-END EVALUATION AND PLANNING (NDYEP)**

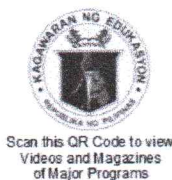


