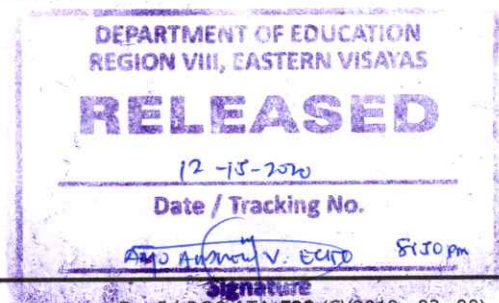

SUBJECT: **Extension in the Submission of LDM 2 Outputs and Evaluation Forms**

DATE: 25 November 2020

1. Considering the series of typhoons that greatly affected a number of schools division offices as well as the ongoing pandemic, item 9 of the NEAP memo dated October 20 is hereby repealed.

9. LDM2 pre-implementation (Module-based) outputs shall have all been submitted by the end of October and be evaluated by the last week of November. Should an extension in the submission and evaluation of the theoretical outputs be needed, in consideration of the context of the division/region, NEAP-R focal persons are requested to relay this request to the LDM Program Management Team.

2. Regions and divisions, through the guidance from NEAP-R, are given the authority in setting the deadlines for the outputs to be submitted. They are advised to consult with LDM coaches, LAC leaders, and participants in determining the length of extension needed in submitting the theoretical (module-based) outputs and evaluation forms. Everyone is also urged to exercise leniency, flexibility, and compassion in setting deadlines for these requirements.

3. Consequently, evaluators are also instructed to relax the timeliness criterion in the evaluation rubric.

4. Regional and division LDM Program Management Teams are encouraged to update and use the LDM trackers, and the submission of LDM evaluation forms as these provide information on the progress of submissions.

5. NEAP is thankful to everyone for being able to forge ahead, learn, and improve our systems as we do.
