### VIRTUAL WORKSHOP ON PRACTICAL ASSESSMENT AND MONITORING STRATEGIES IN INCLUSIVE EDUCATION UNDER THE NEW NORMAL

- 1. As part of the efforts of the Region to realize the objectives of the Basic Education Learning Continuity Plan (BE-LCP) and the mandate of inclusive education, this Office, through the Curriculum and Learning Management Division, shall conduct a Virtual Workshop on Practical Assessment and Monitoring Strategies in Inclusive Education Under the New Normal on December 29, 2020 via Zoom.
- 2. The one-day activity aims to:
  - a. orient the SPED Supervisors on some assessment and monitoring strategies that have proven useful in the time of the pandemic;
  - b. give updates on the significant interventions that the Divisions employed in addressing issues in inclusive education;
  - c. conduct a needs assessment on the lacking learning resources for learners with disabilities, particularly the blind, deaf, and those with low vision;
  - d. enhance the SPED Monitoring Tool; and
  - e. discuss the proposed inclusive education quality indicators that can be used for program monitoring.
- 3. The participants to the activity shall be the Regional and Division Special Education Supervisors who are expected to use the monitoring tool and quality indicators and invited SPED Teachers who shall share their best practices on inclusive education which have been useful despite the pandemic.
- 4. Attached to this Memorandum is the Activity Matrix (Enclosure A) specifying the schedule, topics for discussion, and personnel involved during the activity.
