SUPERVISORY DEVELOPMENT COURSE (SDC) TRACK 1

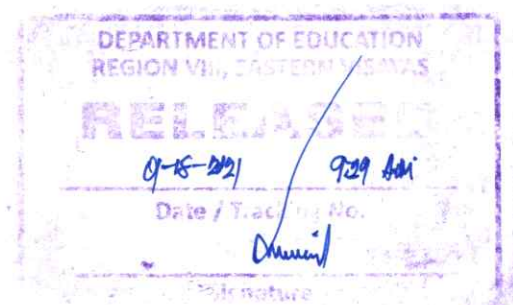
