REGIONAL MEMORANDUM

**VIRTUAL SENIOR HIGH SCHOOL (SHS) PROGRAM IMPLEMENTATION REVIEW
FOR CALENDAR YEAR 2020**

To: Schools Division Superintendents
All Others Concerned

1. In order to continue the mandate of monitoring and evaluating the Senior High School (SHS) Program implementation and in response to the findings observed by the Regional Inspectorate Team for Establishment of Schools, this Office, through the Curriculum and Learning Management Division (CLMD) in coordination with the Quality Assurance Division (QAD), shall conduct a Virtual Senior High School Program Implementation Review for Calendar Year 2020 on January 19, 2020 via Zoom.
2. The activity aims to:
 - a. revisit SHS policy guidelines on the application of additional offering;
 - b. review and finalize SHS Curricular Exit and National Certification data;
 - c. map-out TVL specialization offering;
 - d. identify and discuss operational issues as a way of assessing SHS operation; and
 - e. offer possible solutions to better improve the implementation.
3. The participants to this activity are the CLMD OIC-Chief, RO and SDO SHS and TVL Focal Persons, and RO SHS Focal Person for Private School.
4. The SDO SHS Focal Persons are expected to update the Google Sheets on the SHS Curricular Exit and National Certification data which shall be shared during the consultation meeting with the Presidents of the state universities, and colleges on the last week of this month.
5. The meeting link and access to the attendance forms shall be shared to the participants through the Facebook messenger.



6. It is required that a Division-Based Program Implementation Review for Calendar Year 2020 be conducted within the month of March, 2021 as a cascading activity to ascertain the uniformity of information at the school level to better improve the SHS program implementation.
7. Further, in order to keep track of the status of implementation of the SHS program even in this pandemic, the Schools Division Offices through the Division SHS Focal Persons are expected to ascertain the accomplishment of the Online Survey on the Program Implementation by the Public Senior High School Program Implementers (preferably the School SHS Coordinators) using the link: <https://bit.ly/2UPO3ky> not later than January 25, 2020.
8. Immediate dissemination of and compliance with this Memorandum are desired.

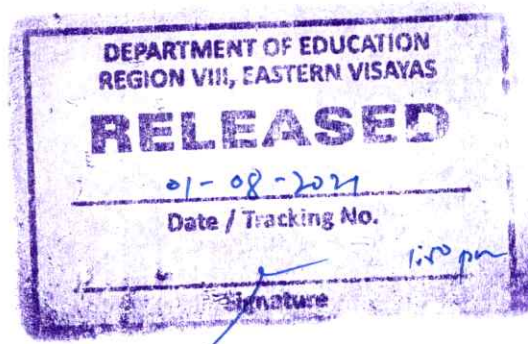
