

This refers to the Republic Act No. 11519¹ and 11520² extending the availability of appropriations under *Bayanihan* Act (BA) 2 and fiscal year (FY) 2020 General Appropriations Act (GAA), respectively. This Office reminds all concerned offices of the validity of funds sourced from the following laws that were released/downloaded to regional and schools division offices for the implementation of BE-LCP:
