**REITERATION ON THE COUNTERPART OFFICES
ACROSS DEPED ORGANIZATIONAL LEVELS**

To: Schools Division Superintendents
Regional Office Division Chiefs and Section/Unit Heads
All Others Concerned

1. Pursuant to Executive Order No. 366, s. 2004 which aimed to improve the quality and efficiency of government services delivery by eliminating/minimizing overlaps and duplication of functions, and improving agency performance through the rationalization of organizational structure and staffing, this Office reiterates the enclosed counterpart offices of each organizational level per DepEd Order No. 52, s. 2015.
2. Relative to this, the Regional Office Division Chiefs are requested to revisit their current Schools Division Office counterparts and align them to the prescribed structure, and the Schools Division Superintendents to revisit and reorganize their Division focal persons and align their functions to their respective Regional Office counterparts.
3. This issuance aims to develop consistency of assigning counterpart offices and individuals between the Regional Office Divisions and Schools Division Offices and ensure alignment of functions, accountability, and transactions among these levels of governance.
4. Immediate dissemination of and strict compliance with this Memorandum are desired.

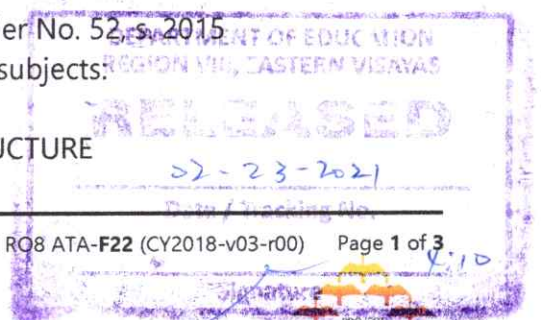
