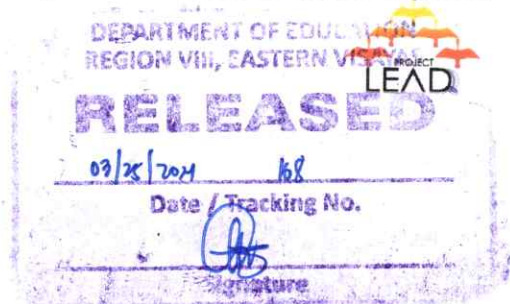

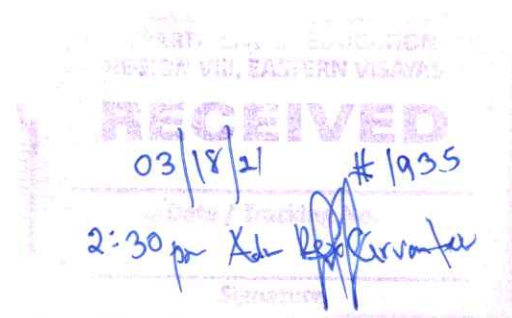

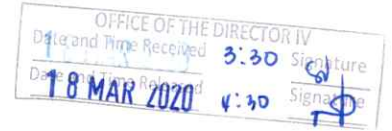

The Department of Education (DepEd) – Alternative Learning System Task Force (ATF), in partnership with United Nations Children’s Fund (UNICEF), Philippines and Southeast Asian Ministers of Education Organization Regional Center for Educational Innovation and Technology (SEAMEO INNOTECH), has developed a teaching and learning resource package for ALS teachers called the **Alternative Learning System ware (ALSware) Package** under the tripartite project: Technical Support to ALS Program 2.0. This resource package will provide selected ALS teachers with useful and relevant materials for effective delivery of the ALS K to 12 Basic Education Curriculum.

In line with this, please be informed of the following activities related to the provision of the ALSware Package:

- I. **Delivery to Division Offices** - the said packages, which include a storage facility (one large steel cabinet, two bags), various printed materials, instructional tools and equipment, and consumable materials, will be delivered from March 22-26, 2021 to selected Schools Division Offices in your regions for subsequent transfer to selected CLCs/school-based CLCs.

The Regional ALS Focal Persons and concerned Division ALS Focal Persons are requested to coordinate with their respective Division Supply Officers for proper inspection, recording of the said packages, and processing of the Deed of Donation.



They are also requested to send the complete address of their Schools Division Offices and their plan and logistical arrangement (e.g., type of transportation to be used) in delivering the packages to the recipient CLCs/school-based CLCs and ALS teachers to Ms. Jenelyn Baylon of the ALS Task Force through email at [jenelyn.baylon@deped.gov.ph](mailto:jenelyn.baylon@deped.gov.ph) on or before **March 19, 2021**.

A short write-up with photos and/or videos of the delivery of the packages to CLCs/school-based CLCs and to ALS teachers is also requested. The said documentation should be forwarded to UNICEF Philippines c/o Mr. Avelino Jr. Mejia through [ajmejia@unicef.org](mailto:ajmejia@unicef.org).

- II. **Delivery to the CLCs/school-based CLCs** – concerned Division ALS Focal Persons are requested to inform the recipients that the ALSware Package utilization shall be in accordance with the *Guidebook for Using the ALSware Package*, which will be made available in the following weeks. The project implementation team will coordinate with the concerned Division ALS Focal Persons and ALSware Package recipients in relation to the detailed inspection of the ALSware Package contents.
- III. **Orientation on the Guidebook for Using the ALSware Package** – ALSware Package recipients are likewise required to participate in the *Orientation on the Guidebook for Using the ALSware Package* on 28 April 2021 (to be confirmed) to ensure appropriate and safe use of the ALSware materials. The project implementation team will coordinate with the concerned Division ALS Focal Persons and ALSware Package recipients in the following weeks.
- IV. **Monitoring of the ALSware Package** – initial monitoring activities will be conducted by the project implementation team. Concerned DepEd Regional and Division ALS supervisors are likewise expected to conduct subsequent monitoring of the ALSware Package utilization, proper care and maintenance. An orientation on ALSware monitoring activities will be facilitated by the project implementation team in June 2021. More information will be provided in the following weeks.
