1. Relative the DepEd Order No. 12, s. 2021, re: "Amendment to DepEd Order No. 30, s. 2020" on the School Calendar and Activities for School Year 2020-2021, this Office hereby sets the schedule of the Quarterly Portfolio Day for S.Y. 2020-2021 as follows:

- 2nd Grading Period - March 6, 2021;
- 3rd Grading Period - May 29, 2021; and
- 4th Grading Period - July 10, 2021.

2. The Schools Division Offices and schools may adopt and follow the modalities and the General Guidelines and Considerations of Distance Learning based on Memorandum DM-CI-2020-00162. In addition, the Divisions are empowered to reschedule the activity if the need arises.

3. The following suggested activities may be included as part of the school's conduct of the Portfolio Day:

- a) Parent-Teacher-Adviser Conference and Feedback Giving;
- b) Showcase of learners' outputs and performances; and
- c) Distribution of learners' progress report cards.

4. The Schools Division Superintendent shall engage the Chiefs of the Curriculum Implementation Division (CID) and the School Governance and Operations Division (SGOD) to plan, organize, and lead in the conceptualization of the conduct of the said activity. Monitoring is required with emphasis on the adherence to DOH and IATF health protocols. Moreover, the SDO shall submit a picto-narrative accomplishment report to clmd.region8@deped.gov.ph a week after the event using the attached Accomplishment Report Template.



5. Immediate dissemination of and compliance with this Memorandum are desired.

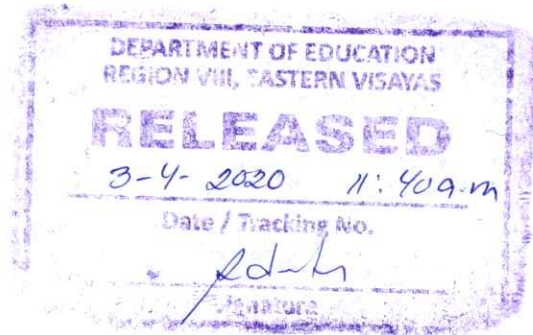
