- g. Submit an annual report consolidating the yearly reports from Schools Division Offices within their respective jurisdictions no later than the first week of December each year to the Central Office-BLSS; and
- h. Conduct an annual Performance Implementation Review of the WinS Program and submit findings and recommendations to the Central Office.

4. Schools Division Superintendents are hereby enjoined to organize their WinS Technical Working Group (TWG) in their respective Division Offices per DepEd Memorandum No. 194, s. 2018.
