



Dear Regional Advisory Council Members,

The Pantawid Pamilyang Pilipino Program or 4Ps has been officially approved as a law, also known as Republic Act 11310 or "An Act Institutionalizing the Pantawid Pamilyang Pilipino program (4Ps) and its Implementing Rules and Regulations last 2019. The 4Ps is the national poverty reduction strategy and a human capital program that provides conditional cash transfer to the poor households to improve the health, nutrition and education aspects of their lives. The enactment of the Republic Act 11310 has institutionalized the implementation of the program thereby providing for a more efficient and effective service delivery to its beneficiaries. The law also defines "institutionalization" as making 4Ps an "added function of the Department of Social Welfare and Development (DSWD) and a regular program funded from its annual appropriation "(Sec. 2.h) and assigning DSWD as its lead implementing agency (Sec. 14).

In the implementation of the Pantawid Pamilyang Pilipino Program, the key partner agencies, as members of the Advisory Councils (Sec. 15), are very important ingredients and play a crucial role to achieve its goals in ensuring the Pantawid Beneficiaries are given proper assistance when it comes to health, nutrition and education. One of the key outcomes of the program on the Partnership Framework is to make the program partners engaged and supportive to the program implementation, it is on this premise that our ties and partnership will be strengthened.

In preparation for the upcoming Regional Advisory Council Meetings this 1st and 2nd semester of 2021 and moving forward, kindly fill out and update our current Database of NGA Partners with all the Programs of Services Available and Accessible for Pantawid Beneficiaries. This is also the easier way for our updating and reporting per agency during our regular meetings.
