This Supplemental Bid Bulletin is issued to clarify, modify, and amend certain provisions/specifications in the Bid Documents for the abovementioned project. It shall form part of the Bid Documents and supersedes provisions therein that are inconsistent herewith.

1. That Section 3, Bid Data Sheet, specifically in ITB Clause 5.2, is hereby amended from **“For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be: *“PROCUREMENT FOR CY 2020 BEFF CONSERVATION AND RESTORATION OF GABALDON SCHOOL BUILDINGS – BATCH 2 - CLUSTER 3”* to “The bidder must have an experience of having completed, within the last five (5) years from the date of submission and receipt of bids, a Single Largest Completed Contract (SLCC) that is similar to the project, equivalent to at least fifty percent (50%) of the ABC adjusted, if necessary, by the bidder to current prices using the PSA’s CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184. For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be: REPAIR, REHABILITATION, RESTORATION, AND/OR CONSTRUCTION OF GENERAL BUILDINGS.”;**
2. That Section 1, Invitation to Bid, specifically Item no. 6, first paragraph, is amended from **“Bids must be delivered to the address below, before 10:00AM of June 14, 2021. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.” to “Bids must be delivered to the address below, on or before 10:00AM of June 14, 2021. All bids must be accompanied by a Bid Security Declaration or any form of Bid Security and amount indicated in the Bid Data Sheet ITB Clause 15.1.”;**



3. That an addendum to Section 2, Instruction to Bidders, item 2.1 is hereby indicated as "The GOP through the source of funding as indicated below for **CY 2020** in the amount of **Php4,852,011.86**;
4. That paragraphs under Section 2, Instruction to Bidders, item 2.2 are for deletion except for paragraph "**a. NGA, the General Appropriations Act or Special Appropriations**" which shall be retained;
5. That paragraph (a) under Section 2, Instruction to Bidders, item 7.1 which states that "**The Procuring Entity has prescribed that: a. Subcontracting is allowed. The portions of Project and the maximum percentage allowed to be subcontracted are indicated in the BDS, which shall not exceed fifty percent (50%) of the contracted Works**" is for deletion, hence, paragraph (b) stating that "**b. Subcontracting is not allowed.**" is retained.;
6. That Section 3, Bid Data Sheet, Clause 7.1 shall provide that "**Subcontracting is not allowed.**";
7. That Section 3, Bid Data Sheet, Clause 10.3 shall provide that there is "**No further instruction.**";
8. That Section 3, Bid Data Sheet, Clause 12 shall provide that there is "**No further instruction.**";
9. That Section 3, Bid Data Sheet, Clause 18 which states that "The bid security shall be valid until 120 calendar days." is actually **Clause 15.2.**;
10. That Section 3, Bid Data Sheet, Clause 20.3 is actually **Clause 16** while its provision stipulated remains in force.;
11. That Section 3, Bid Data Sheet, Clause 20 shall state that "**Post Qualification:**  
To facilitate post-qualification, the bidder **at its option** may submit in advance, i.e. on the deadline for submission and receipt of bids, the documents required in Section II. ITB 20, in a separate envelope as follows:
  1. **Latest income and business tax returns:** Printed copies of the **Electronically Filed Income Tax/Business Tax Returns** with copies of their respective **Payment Confirmation Forms** for the immediately preceding calendar/tax year from the authorized agent bank;  
**Only tax returns filed and taxes paid through the BIR electronic Filing and Payment System (EFPS) shall be accepted.**
  2. **PhilGEPS Certificate of Membership (Platinum), in case the bidder opts to submit Class "A" Legal Documents during submission and opening of bids.**

That Section 3, Bid Data Sheet, Clause 21 is amended from **“Additional contract documents relevant to the Project that may be required by existing laws and/or the Procuring Entity, such as construction schedule and S-curve, manpower schedule, construction methods, equipment utilization schedule, construction safety and health program approved by the DOLE, and other acceptable tools of project scheduling.”** to **“Signing of the Contract – Other Documents Forming Part of the Contract**

**Additional contract documents relevant to the project are required by the Procuring Entity and shall be submitted by the successful bidder within ten (10) calendar days from successful bidder’s receipt of the Notice of Award, such as:**

- 1. Construction Schedule and S-curve;**
- 2. PERT/CPM;**
- 3. Manpower Schedule;**
- 4. Construction Methods;**
- 5. Equipment Utilization Schedule, and**
- 6. Construction Safety and Health Program approved by the Department of Labor and Employment**

13. That Section 5, Special Conditions of Contract, Clause 2 shall state that **“Completion of Works is within one hundred twenty (120) calendar days upon receipt of the Notice to Proceed.”;**

14. That Section 5, Special Conditions of Contract, Clause 4.1 shall state that **“The Procuring Entity shall give possession of all parts of the site to the contractor after submission of the notarized contract by the contractor to the Procuring Entity and on or before date of receipt of the NTP by the contractor.”;**

15. That Section 5, Special Conditions of Contract, Clause 6 shall state that **“The site investigation reports are: None”;**

16. That Section 5, Special Conditions of Contract, Clause 7.2 shall state that **“The warranty against Structural Defects/Failures**

**The warranty against Structural Defects/Failures, except that occasioned-on force majeure, shall cover the period stated hereunder and shall be reckoned from the date of issuance of the Certificate of Final Acceptance by the Procuring Entity. Five (5) years”;**

17. That the following Bidding Forms shall be added to the bidding documents as annexes, to wit:

- a. Bid Form
- b. Form of Contract Agreement
- c. Omnibus Sworn Statement
- d. Bid Securing Declaration

18. That the title of the abovementioned procurement as indicated in Section II, Instruction to Bidders, Clause 1, shall include the **cluster number** for distinction of specific project which shall be indicated as **Procurement for CY 2020 BEFF Conservation and Restoration of Gabaldon School Buildings Batch 2 – Cluster 3.**

All provisions in the Bidding Documents indicating **Procurement for CY 2020 BEFF Conservation and Restoration of Gabaldon School Buildings Batch 3-Cluster 3** are hereby corrected and shall be indicated as **Procurement for CY 2020 BEFF Conservation and Restoration of Gabaldon School Buildings Batch 2 – Cluster 3.**

19. That the Approved Budget for the Contract (ABC) specified in words, stipulated in Section 1, Invitation to Bid, specifically Item no. 1, is hereby corrected from **"Four Million Eight Hundred Fifty Two Thousand Eleven and 86/100 Pesos Only"** to **"Four Million, Eight Hundred Fifty-Two Thousand, Eleven Pesos and 86/100 Only."**
