Subject : BID BULLETIN NO. 1

Date : June 7, 2021

This Supplemental Bid Bulletin is issued to clarify, modify, and amend certain provisions/specifications in the Bid Documents for the above-mentioned project. It shall supersede provisions therein that are inconsistent herewith.

1. That in the Invitation to Bid (IB) the following are amended as follows:
 - **Item no. 1.** That the phrase “ ... of One Million Pesos Only (Php1,000,000.00) being the Approved Budget for the Contract (ABC)...” shall be changed to “...corresponding each Lot in the table below, being the approved Budget for the Contract (ABC) to payments under the contract for each Lot...”
 - **Item no.6.** That the statement in the delivery of bids to Bac Secretariat shall be changed from “...before 10:00 AM of June 15, 2021.” to “ ...on or before 10:00 a.m. of June 15, 2021.”
Further, the statement “**All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.**” shall also be changed to “**All bids must be accompanied by a Bid Securing Declaration or any form of Bid Security and amount indicated in the Bid Data Sheet ITB Clause 14.1.**”
2. That in Section II, Instruction to Bidders (ITB), Clause 1, under the Scope of Bid, the phrase “**under a Framework Agreement**” shall be deleted.
3. That in Section III, Bid Data Sheet (BDS), the following are amended as follows:
 - An addendum to Clause 5.3. “**Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA 9184, the bidder shall have, within the last five (5) years from the date of submission and receipt of bids, a Single Largest Completed Contract (SLCC) that is at least one (1) contract similar to the project of the value of**



which adjusted to current prices using the PSA's CPI, must be at least equivalent to:

- a. **For the procurement of Non-Expendable Supplies and Services: The bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC."**
- Clause 7.1 shall be inserted with the statement **"Sub-contracting is not allowed"**.
 - An addendum to Clause 14.1. **"There must be a separate Bid Security for Each Lot"**.
 - Clause 15 shall be inserted with the instruction:
"Sealing and Marking of Bids
Number of copies of the bid to be submitted
Each Bidder shall submit one (1) original, and two (2) copies of the Technical Component, and one (1) original and two (2) copies of the Financial Component of its bid.
Failure to submit the required originals of the Technical Component documents and the required originals of the Financial Component documents is a ground for rejection or disqualification of the bid(s).
Failure to submit copies of the same documents mentioned above is not a ground for rejection or disqualification of the bid(s). However, bidders are strongly encouraged to submit the additional copies to facilitate objective and efficient examination of their bids."
 - An addendum to Clause 20.2.
"Post Qualification:
To facilitate the post-qualification, the bidder at its option may submit in advance, i.e. on the deadline for submission and receipt of bids, the documents required in Section II. ITB 20 in a separate envelope as follows:
 1. **Latest income and business tax returns: Printed copies of the Electronically Filed Income Tax/Business Tax Returns with copies of their respective Payment Confirmation Forms for the immediately preceding calendar/ tax year from the authorized agent bank;**
Only Tax returns filed and taxes paid through the BIR electronic Filing and Payment System (EFPS) shall be accepted.
 2. **Philgeps Certificate of Membership (Platinum), in case the bidder opts to submit Class "A" Legal Documents during submission and opening of bids.**



Contract Agreement Form

 - (a) the Supplier’s Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (*e.g.* bidder’s response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity’s bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity’s Notice of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
