This refers to OUF Memorandum No. OUF-2021-0264 dated April 19, 2021, titled "Validity of Bayanihan Acts I and II Releases," which presented a summary of allotments released, chargeable against the Bayanihan Act II Special Appropriations, among others, as summarized in the table below.

However, please ensure that obligations have already been incurred as of this date, and goods and services have already been delivered, inspected and accepted, and payments are made on or before June 30, 2021.
