2. Immediate dissemination of and compliance with this memorandum are desired.

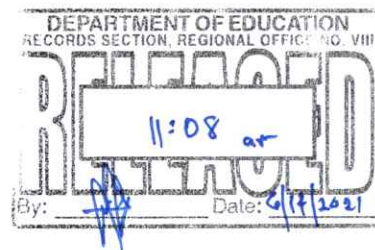

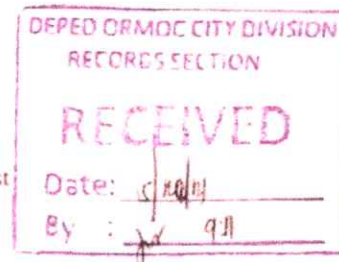
