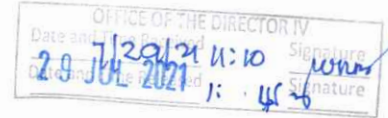



Per Implementing Rules and Regulations (IRR) of Republic Act No. 10681, an Act Establishing Rural Farm Schools as Alternative Delivery Model of Secondary Education, the Bureau of Curriculum Development (BCD), through the Special Curricular Programs Division (SCPD) drafted a curriculum policy for the implementation of the Rural Farm School. As the policy will go through a validation process, a mapping activity via an online survey will be conducted to determine the status of RFS implementation across the seventeen regions.

The respondents of the said online survey shall be the Regional and Division Supervisors in-charge of the program and school heads of the RFS that have been recognized by the division and regional offices to implement the Program. The result of the online survey is in effect the driving force, as a feedback mechanism, in the conduct of the Focus Group Discussion (FGD) with RFS implementers which is tentatively scheduled on August 12, 2021. Its details shall be communicated in a separate Memorandum.
