URGENT CALL TO UPDATE INFORMATION OF PARTICIPANTS TO THE COURSES OFFERED BY THE PHILIPPINE NORMAL UNIVERSITY UNDER THE NEAP-RECOGNIZED PROFESSIONAL DEVELOPMENT PROGRAMS AND COURSES

To: Schools Division Superintendents
All Others Concerned

1. Attached is the list of identified participants to the courses offered by the Philippine Normal University (PNU) who have not responded yet to the online registration. An email was sent to all registered teachers and school leaders requiring them to accomplish an online registration as an initial step to the enrollment process.
2. With the initial registration, PNU has identified a number of issues and provided corresponding solutions:
 - a. for the **emails that bounced back** to the sender, it is recommended that the registered email address be checked or an alternate email address be provided;
 - b. for the **participants who have not responded yet to the online registration**, it is recommended for the identified participants to check and reply to the message sent by PNU the soonest possible time;
 - c. for **participants who wish to withdraw from the program**, they are advised to submit a letter addressed to Undersecretary Nepomuceno A. Malaluan (Attention: Director John Arnold S. Siena), stating their reason for withdrawing from the program. The letter shall be forwarded as well to the Professional Development Division of NEAP (NEAP-PDD) through neap.pdd@deped.gov.ph. Also, the Schools Division Office (SDO) shall recommend a new participant as replacement to the vacated slot; and
 - d. for **participants who are deemed ineligible to the program**, the SDO shall recommend a new participant to replace the existing one. In reference to DepEd Order No. 082, s. 2020, to be eligible for registration to NEAP Professional Development Programs and Courses, applicants must be public school teachers and school leaders.



3. Enclosed is a template to facilitate the submission of the names of participants as replacement to the vacated slots. The HRD SEPS/EPS II shall accomplish the template and email it to hrdd.region8@deped.gov.ph **on or before August 10, 2021.**

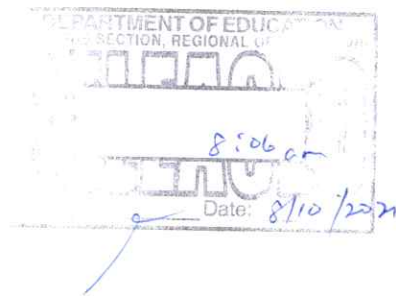
