3. Immediate dissemination of and strict compliance with this memorandum are desired.

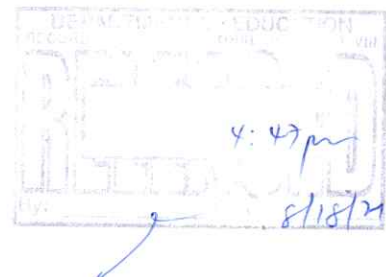
