This pertains to DepEd's request to the Department of Budget & Management for the reclassification of all incumbent Registered Guidance Counselors (RGC) holding Guidance Counselor or Guidance Coordinator positions as of this date.

Relative to this, may we request for an updated inventory of all Guidance and Counseling items in your jurisdiction. This is just an update of the submission of field offices based on the Memorandum DM PFO-2018-0211 dated February 6, 2018 signed by then Undersecretary Jesus LR Mateo. (Please see attached).

The RGC database inventory shall also be utilized to determine strategic interventions or programs needed by DepEd such as capacity building and career development among others. These would strengthen the promotion and delivery of mental health services in basic education through the hiring and deployment of mental health professionals as articulated in the "Basic Education Mental Health and Well-Being Promotion Act" which is pending in the Congress.

The Department of Education recognizes the vital role of the Guidance and Counseling personnel in ensuring that all students in public schools are able to avail of guidance services and programs.

However, the existing salary structure of the Guidance and Counselling positions is not commensurate with the high qualification standards for Guidance Counselors required by RA 9258 s.2004: An Act of Professionalizing the Practice of Guidance and Counseling . Hence, the Department of Education is currently reviewing the status and the salary structure of the guidance services groups.
