

# ACCOMPLISHMENT OF THE MONITORING TOOL ON THE UTILIZATION OF THE KINDERGARTEN HOME-BASED LEARNING FACILITATORS TOOLKIT

To: Schools Division Superintendents

All Others Concerned

- 1. In reference to the attached Regional Memorandum No. 411, s. 2021 on the Virtual Consultative-Workshop on the Contextualization of the Monitoring Tool on the Utilization of the Kindergarten Learning Resources, this Office, through the Curriculum and Learning Management Division (CLMD), requires all the Schools Division Offices to facilitate the accomplishment of the online monitoring tool on the utilization of the Home-Based Learning Facilitators (HBLF) Toolkit by the target parent-respondents starting August 30, 2021 to September 10, 2021.
- 2. The activity aims to gather significant feedback from the parents as the main users of the HBLF Toolkit. The experiences shared by the parents shall help in the enhancement of the said toolkit.
- 3. The Division Kindergarten Focal Persons are directed to randomly select only one (1) parent-respondent from each of the different schools which shall also be chosen through random sampling.
- 4. Attached is the distribution of the expected number of parents per division who shall accomplish the contextualized monitoring tool. The link to the tool shall be shared by the Division Coordinators to the sample schools.
- 5. There shall be a workshop on the harvesting and analysis of the data gathered on September 21, 2021 at 8:00 a.m. to 5:00 p.m. to be attended by the Division Kindergarten Coordinators. For the success of the activity, all the concerned participants are required to have a laptop and a stable internet connection in the entire duration of the workshop.


