  - 2.4 identify courses of action to be undertaken and provide necessary technical assistance to address concerns and bottlenecks in the implementation of PPAs;
  - 2.5 share best practices and valuable lessons of each region;
  - 2.6 orient regional offices in the preparation of Budget Accountability Report (BAR-1) and other M & E reports; and
  - 2.7 provide technical assistance and guidance in adjusting the Work and Financial Plans (WFPs) including the use of the Program Management Information System (PMIS).
