1. In line with DepEd Memorandum No. 194, s. 2018 re: Implementing Guidelines to DepEd Order No. 10, s. 2016, this Office, through the Field Technical Assistance Division (FTAD) in coordination with the Education Support Services Division-Health and Nutrition Unit (ESSD-HNU), CLMD, UNICEF and CHSI Philippines will conduct an Online Orientation Workshop for Regional Implementation of the #MeronAko MHM Learning Package on September 2-3, 2021 via Zoom.
