

- The Department of Education (DepEd) issues the enclosed Counseling and Referral 1. System for Learners for S.Y. 2021-2022, which aims to give DepEd schools the mechanism to address the needs of learners on mental health services including counseling activities with mental health professionals.
- In response to the mental health concerns of learners as stipulated in Republic Act 2. 11036 or the Mental Health Law, this memorandum institutionalizes the guidelines and procedures that will aid public schools in addressing the mental health concerns of Filipino learners.
- This policy shall be implemented in all public elementary and secondary schools 3. nationwide for S.Y. 2021-2022.
- Immediate dissemination of and strict compliance with this memorandum is 4. directed.
