1. Pursuant to Regional Memorandum No. 537, s. 2021 entitled DepEd Sports Skills Demonstration Contest, the regional search is scheduled on October 15, 2021. However, due to procurement issues raised by the participating schools, the following dates shall be considered:

 - b. **October 25-26, 2021** – Regional Contest
3. The participating schools are reminded to submit their delegation composition and the corresponding athletes' documents based on Regional Memorandum No. 537, s. 2021, through the same e-mail address previously stated.
4. All other conditions in the previous memorandum are still enforced.
5. Relatively, the Regional Delegation is organized to carry out the tasks in conducting the regional search and represent the region to the national level contest (Refer to the Attachment). All concerned are advised to coordinate with Mr. Cesar P. Verunque, Chief, ESSD for their specific assignments.



6. All expenses relative to the successful conduct of the said activity shall be charged against the program support fund downloaded from DepEd Central Office for the purpose, subject to the usual government accounting and auditing rules and procedures.
7. Immediate dissemination of and strict compliance with this memorandum are desired.

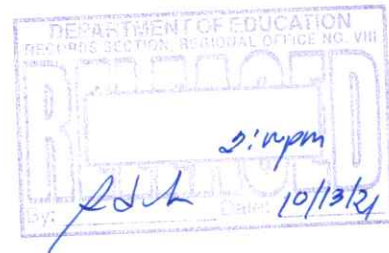
