

The *Sining Pangkabuhayan para sa Kabataan* (SPK) is the Department of Education's (DepEd) program in support to Republic Act (RA) No. 10066, otherwise known as the "National Cultural Heritage Act of 2009," which pursues cultural programs and presentations as a strategy for promoting Filipino identity. This is also consistent with Article 2, Section 17 and Article 14, Section 14-18 of the 1987 Constitution, and the Agenda No. 6 of Secretary Leonor Magtolis Briones' 10 Point Agenda which promotes Filipino arts and culture.

The SPK showcases skills and talents and arts and crafts, and provides workshops to learners and teachers to strengthen arts and culture. It aims to provide real-life opportunities for learners to realize that their art productions are valid means of livelihood.

In consideration of the IATF rules and DepEd issuances in conducting activities due to the COVID-19 restrictions, DepEd through its External Partnerships Service (EPS) shall conduct the 2021 SPK virtually. It shall be a three-day event where learners

and teachers can market and promote their arts and crafts. The 2021 SPK is proposed to be conducted in **November 24-26, 2021**.

In this regard, a series of planning, consultative and coordination meetings shall be held in preparation for the conduct of said virtual 2021 SPK activities. The schedule of the meetings are as follows:
