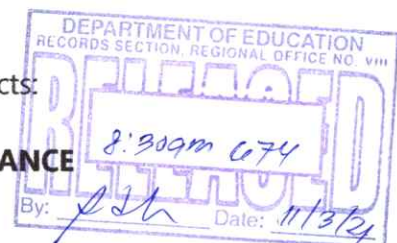

1. For consistency in the practice of promoting the principle of continuous improvement (CI) in the operation and implementation of the Monitoring and Evaluation (M&E) System with the MEA Technology in all levels of governance in DepEd Regional Office VIII and sustainability of its responsiveness to the current trends in the delivery of basic education services, this Office, through the Quality Assurance Division (QAD), announces the conduct of the two-day Regional Virtual Monitoring and Evaluation (M&E) Summit via zoom platform on November 3-4, 2021.

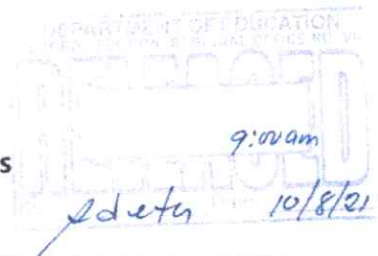
7. To comply with the IATF protocols, the Regional Office participants are hereby advised to strictly observe the required health and safety standards.
