1.  - d. identify the innovative, effective, and best practices on TA provisions of the SDOs for recognition in the region during the TA Implementation Review cum SBM Summit.

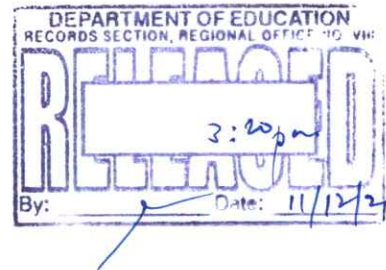
