**UPSKILLING OF SCHOOL HEADS ON INCLUSIVE EDUCATION**

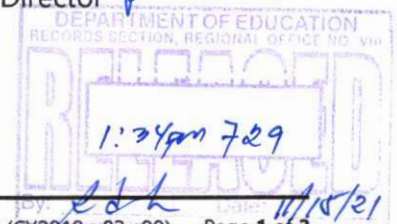
