1. In reference to the approved Securities and Exchange Commission (SEC) Registration with Registration No. A199917914 of St. Scholastica's College Tacloban, Inc., Brgy. Campetic, Maharlika Highway, Palo, Leyte, Philippines through the Quality Assurance Division (QAD) announces the change of name of school from St. Scholastica's College of Health Sciences, Inc. to St. Scholastica's College Tacloban, Inc. effective **November 18, 2021**.
2. The change of name does not instill any deviations on the provisions of the Government Recognition given to the said school. Thus, Government Recognition Nos. 0005, s. 2016 for Kindergarten, 006, s. 2016 for Elementary, 015, s. 2014 for Junior High School, and 055, s. 2015 for Senior High School respectively still remain legal and official.

**AMENDED ARTICLES OF INCORPORATION
OF ST. SCHOLASTICA'S COLLEGE TACLOBAN, INC.
(FORMERLY: ST. SCHOLASTICA'S COLLEGE OF HEALTH SCIENCES, INC
(as amended on July 20, 2009)**

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the Laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of the said association shall be:

**ST. SCHOLASTICA'S COLLEGE TACLOBAN, INC.
(FORMERLY: ST. SCHOLASTICA'S COLLEGE OF HEALTH SCIENCES, INC)
(as amended on July 20, 2009)**

SECOND: That the purposes for which said association is formed are the instruction and education of the:

1. Kindergarten, Grades 1-12
(as amended on July 16, 2014)
2. Technical Vocation Education and Training (TVET)
3. Tertiary and Graduate Programs
(as amended on September 25, 2009)

To receive tuitions and miscellaneous fees, accept donations, endowments, grants, legacies and instruments/devices conformably with existing applicable statues.

Provided that this registration with the Securities and Exchange Commission shall not be construed as a grant to operate the school and that the establishment, operation, administration of authority and management of this school be subject to existing laws, rules and regulations or policies and standards of Batas PambansaBlg. 232 otherwise known as the Education Act of 1982 and RA 7722 and of Dep.Ed., TESDA and CHED. (as amended on September 25, 2009)

THIRD: That the principal office of the association is located in Brgy. Campetic, Maharlika Highway, Palo, Leyte, Philippines.
(as amended on July 16, 2014)

FOURTH: That the term for which the said association is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.
