

DOWNLOADING OF FUNDS TO THE DIVISION OF SAMAR IN SUPPORT TO THE FACILITATION OF AND LOGISTICAL REQUIREMENT FOR THE OCULAR VISIT OF THE DEPED CENTRAL OFFICE MONITORS ON THE PILOT IMPLEMENTATION OF THE FACE-TO-FACE ALTERNATIVE LEARNING SYSTEM (ALS) CLASSES

- 1. Relative to the recently concluded online meeting with the identified participants, per attached Office Memorandum OM 625, s. 2021 dated 24 November 2021, and with the change in the itinerary of our DepEd Central Office visitors, this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download funds to the Schools Division of Samar in the amount of Twenty-Eight Thousand Pesos (**Php28,000.00**) to be taken from the downloaded 2021 Program Support Funds for the ALS bearing the Sub-ARO Number **OSEC-8-21-2610**.
- 2. The said funds shall be used to cover the expenses incurred in support to the facilitation of and logistical requirement for the ocular visit of the DepEd Central Office monitors on the pilot implementation of the face-to-face Alternative Learning System (ALS) classes, and other activities relative to the above-mentioned visit.
- 3. The Schools Division Superintendent concerned, through the Chief of the Curriculum Implementation Division, shall submit a financial report on the utilization of the downloaded funds a week after the visit to clmd.region8@deped.gov.ph cc alfredo.cafe@deped.gov.ph.





Further, there shall be a regional monitoring and technical assistance provision by the next quarters, through any authorized modality, to check the status of the piloting and of the previous downloaded funds intended for the ALS Program implementation in order to enhance the absorptive capacity of the Schools Division Office.
- 5. All expenses incurred during the conduct of the regional monitoring shall be charged against the downloaded Program Support Funds for the ALS.


