ALTERNATIVE LEARNING SYSTEM (ALS) FACE-TO-FACE CLASSES**

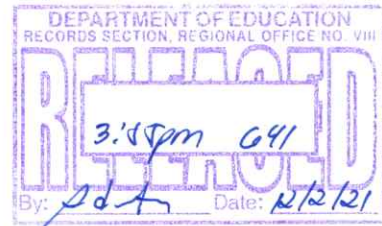
1.
