**DOWNLOADING OF THE REMAINING ALTERNATIVE LEARNING SYSTEM (ALS)
PROGRAM SUPPORT FUNDS (PSF) IN FISCAL YEAR 2020
TO THE RECIPIENT SCHOOLS DIVISION OFFICES**


1. In support to the continued effort in ensuring a quality learning continuity in the Alternative Learning System (ALS) Program across the region, and with the recommendation from the majority of the Division ALS Focal Persons, this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download funds, through a funding check arrangement, amounting to Five Hundred Thirty Thousand Pesos (**Php530,000.00**) to the recipient Schools Division Offices following the breakdown specified in the enclosure.
2. The funds shall be used to cover the expenses incurred in the monitoring, reproduction of learning materials, procurement of office supplies, and other activities in support to the online learning modalities from the fourth quarter of Calendar Year 2021 to the third quarter of the Calendar Year 2022 relative to the implementation of the above-mentioned Program.
3. The Schools Division Superintendents, through the Chiefs of the Curriculum Implementation Division, shall submit a financial report on the utilization of the downloaded funds on or before January 14, 2022 to clmd.region8@deped.gov.ph cc alfredo.cafe@deped.gov.ph.
4. Further, there shall be a regional monitoring and technical assistance provision during the first quarter of Calendar Year 2022, through any authorized modality, to check the status of utilization of the previous downloaded funds intended for the ALS Program implementation in order to enhance the absorptive capacity of the Schools Division Offices.



5. All expenses incurred during the conduct of the regional monitoring shall be charged against the downloaded Program Support Funds for the ALS.
6. All queries shall be sent through the aforementioned email addresses.
7. Immediate dissemination of and compliance with this Memorandum are desired.


